Together, we've fostered a thriving ecosystem, advancing the development and adoption of Smart Health technologies across Europe.

This journey has been filled with opportunities, collaborations, and innovations, and while challenges remain, we take pride **in our collective achievements over the course of this project:**

Our Key Achievements
